

NEW SHARPS LAW NOW ENFORCED!

To comply with the September 2008 sharps law, never discard sharps in any waste container. The new law requires that all home-generated sharps be placed in approved red bio-hazard containers for transport to and management by approved hazardous waste facilities, medical waste generators, pharmacies, medical clinics or needle mail-back programs. Illegally discarded sharps place everyone at risk of needle-prick injuries and contagious diseases—especially sanitation workers who manually separate recyclable and hazardous materials from the waste stream.



WHAT ARE SHARPS?

Sharps include syringes, needles and lancets used in the medical treatment of people and animals.

DON'T DISCARD SHARPS IN TRASH, RECYCLING CONTAINERS OR TOILETS!

Sharps placed in the trash at home, school or other public places may fall out of containers, stick out of trash bags, or fall to the ground. Sharps flushed down toilets end up at sewage plant facilities. The result — a serious health risk to people and animals coming in contact with contaminated sharps!



HOW TO SAFELY & LEGALLY DISCARD SHARPS

Take these three simple steps:

- 1 Call Delta Household Hazardous Waste
 Collection Facility at (925) 756-1990 to
 request a BD™ Home Sharps Container by
 mail. The container is made for the disposal
 of insulin syringes and pen needles only. Other
 types of syringes do not fit. It holds 70-100
 insulin syringes or 300 pen needles. Syringe
 capacity depends on the size of the syringe.
- When you receive the Sharps Container in the mail, fill it with syringes, needles and/or lancets, following container directions.
- 3 Deliver full Sharps Containers to Delta Household Hazardous Waste Collection Facility and pick up another free container.
