



Ensuring Long-term Financial Sustainability Proposed Sewer Service Charge Increases

April 2024

In developing its budget each year, Delta Diablo (District) carefully considers operational and capital investment needs to maintain effective and reliable wastewater collection (Bay Point only), conveyance, and treatment services for over **218,000 customers** in Antioch, Pittsburg, and Bay Point. Our primary revenue source comes from **Sewer Service Charges (SSCs)*** charged to residential, commercial, and industrial customers on the tax roll each year.

We continue to prioritize sustained **capital investment** to maintain the integrity of our **aging wastewater system infrastructure****, while ensuring sufficient funding to meet **progressive increases in annual operating costs** over time due to escalations in labor, chemical, energy, materials, supplies, equipment, hauling, and services costs, as well as **increasingly more stringent regulatory requirements**.

We critically review required SSC adjustments to ensure sufficient revenue collection that reflects cost-of-service, while minimizing economic impacts to customers. For **Fiscal Year 2024/25** (effective July 1, 2024), the District has notified customers (via **Proposition 218 Notices***** mailed to property owners on or before April 19, 2024) of its intent to increase SSCs for residential customers by **\$24.80/year** (+5.5%, \$473.55 total) for **Antioch/Pittsburg** and **\$33.16/year** (+5.4%, \$648.93 total) for **Bay Point**.

- **SSC Revenue Allocation:** We have identified a total SSC revenue need of **\$39.2 million** for FY24/25, which includes \$25.2 million for operational needs and \$14.0 million for capital project funding. Other funding includes ad valorem taxes and available unallocated funds.
- **Annual Revenue Increase Drivers:** The proposed SSC increase would generate an **additional \$2.5 million in revenue** in FY24/25 to support cash funding of critical capital investments in aging infrastructure and operating cost increases in key categories.
- **Nutrient Removal Requirements:** Along with peer wastewater agencies in the San Francisco Bay Area, the District faces a regulatory mandate to remove nutrients (e.g., ammonia) from wastewater, which will require an estimated \$120-140 million in capital investments at the District's Wastewater Treatment Plant over the next decade.
- **Strategic Planning:** The District faces challenges related to aging infrastructure, meeting regulatory drivers, navigating a competitive labor market, and effectively engaging with the local community to ensure sustained organizational improvement. The District's Strategic Plan (dated August 2021), coupled with leadership by our Board of Directors, provides a **strategic framework that will guide key decisions, initiatives, and activities**.
- **Long-term Financial Planning:** We prepare a 5-year financial plan (with a 10-year outlook) to identify future SSC adjustments to **maintain financial sustainability**, while avoiding sharp rate increases. The **District continues to maintain its rates below the average** of peer agencies in the San Francisco Bay Area.

* SSCs are not used for recycled water or street sweeping services, which are funded separately.

- ❖ Reusing residual biosolids as fertilizer through land application at farm sites
- ❖ Providing household hazardous waste (HHW) collection services
- ❖ Protecting the Delta by providing street sweeping services
